**Sub:- Appointment of Expenditure Observers for General Elections
to 11 Municipal Councils.**

O R D E R

Whereas the General Elections to 11 Municipal Councils in the State of Goa are scheduled to be held on 25/10/2015.

And whereas the State Election Commission is vested with the power of Superintendence, direction and control of the Municipal Elections to ensure free and fair elections.

Now, therefore, in exercise of the powers vested in me under Article 243 ZA of the Constitution of India read with Section 10A of The Goa Municipalities Act, 1968, I, the undersigned, State Election Commissioner, Goa, do hereby appoint the following Officers of Government of Goa as **Observers (Expenditure)** for the Municipal Councils shown against their names herein below for the purpose of General Elections to 11 Municipal Councils to be held on 25th October, 2015.

The Observers (Expenditure) appointed herein shall monitor the Election Expenditure incurred by each of the candidates of respective Municipality and accordingly submit periodical reports to the concerned Returning Officer and the District Collector/Municipal Council District Election Officer.

The services of above appointed Officers are hereby requisitioned for the Municipal Elections with immediate effect and till the entire process of Municipal Elections is over. The concerned Head of the Department/Head of Office/Controlling Officers shall immediately relieve the above Officers so as to report for training on 08.10.2015 at 10.00 a.m. at Conference Hall, Office of Joint Chief Electoral Officer, Altinho, Panaji, Goa.


The Expenditure Observers shall report to concerned RO's and start functioning so as to monitor the expenditure incurred by the candidates and submit the report to the Returning Officer. The Expenditure Observers shall ensure that there is no violation of Model Code of Conduct by the candidates while incurring Election Expenditure and any such violations noticed shall be immediately brought to the notice of the Returning Officer.

The Expenditure Observers shall submit their final report on 28/10/2015 latest by 4 00 p.m. to the respective MCEO's for onward submission to this Commission.

The Officers who are appointed as Expenditure Observers and kept in Reserve shall attend the training on 08/10/2015 and shall thereafter report to this Commission for further instructions.

The respective Head of Department/Head of Office/Controlling Officer under whom the above appointed Officers are working shall relieve them on 08/10/2015 at 9 30 a.m. for attending training and shall provide them the Office vehicle with driver for first journey to attend the training. Thereafter, the concerned Returning Officer shall make necessary arrangements for effective functioning of the Expenditure Observer.

Attention of all the Controlling Officers is hereby invited to the Circular no.13/5/2011-Per dated 28/09/2011 issued by the Department of Personnel, Government of Goa regarding the independent and effective functioning of the State Election Commission. The Controlling Officers shall ensure that there is no laxity on their part in relieving the appointed Officers and any such instances shall be viewed seriously.
