Now, therefore, in exercise of the powers vested in me under Article 243 ZA of the Constitution of India read with Section 10A of The Goa Municipalities Act, 1968, I, the undersigned, State Election Commissioner, Goa, do hereby appoint the following Officers of Government of Goa as **Observers (General)** for the Municipal Councils shown against their names herein below for the purpose of General Elections to 11 Municipal Councils to be held on 25th October, 2015.

The Observers (General) appointed herein shall monitor the Election process of respective Municipality and accordingly submit periodical reports to concerned District Collector/Municipal Council District Election Officer and this Commission.



- b) In case of any irregularities noticed by the Observer, Returning Officer may be directed to initiate action as per provisions of Law and Model Code of Conduct in force under intimation to the State Election Commission so as to conduct election in free & fair manner. For this purpose the Observer is permitted to use Telephone/Fax facilities available in the Office of the Returning Officer.
- c) Copies of the following documents may be collected at the earliest:
- i. Authority letter to enter the polling stations and place of counting.
 - ii. Car pass for Observer
 - iii. List of Polling Stations.
- d) Two copies of passport size photograph may kindly be made available to the Commission for the purpose of issuing a badge to the Observer.
- e) The Observer will have to submit to the State Election Commission immediately after the last day of counting of votes, a brief note containing his observations at the time of polling and counting alongwith his suggestions, if any.
- f) The Observer shall use his own official vehicle available in his Department/Office.
- g) The Returning Officers shall provide adequate security and support services such as providing fuel, stationery, etc. to the Observer.
- h) The respective HOD's under whom the above appointed Officers are working shall provide him/her office vehicle and a driver with adequate petrol for first journey.
- i) **The respective Controlling Officers shall relieve them on 08th, October, 2015 without fail for enabling them to perform the duties as Observer (General).**


